| 2 | FY2008 Food Distribution Program Tribal budget in the amount of \$74,760.71; and |
| 3 | WHEREAS, the Nation was notified of the final grant award for USDA budget which funding is at |
| 4 | a 75% match by USDA and a 25% match by Tribal funds; and |
| 5 | WHEREAS, the Tribal match has increased from \$74,760.71 to \$78,032.35 with a difference of |
| 6 | \$3,271.80; and |
| 7 | WHEREAS, the Executive Branch developed and obtained committee approval for the Department |
| 8 | of Health and Human Services, Tribal Food Distribution Program Budget Amendment |
| 9 | #1 which increases the Food Distribution Program Tribal funding by \$3,271.80 and |
| 10 | increases/decreases and adds new line items: Communication Expense, Supplies |
| 11 | Office, Supplies Other and RM Building, to be effective October 01, 2007 through |
| 12 | September 30, 2008, and requests authorization to expend these funds. The fund |
| 13 | source is the FY08 surplus funds. |
| 14 | NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby |
| 15 | approve Amendment #1 which reflects the increase of \$78,032.35 and authorizes the |
| 16 | Executive Branch to expend funds in the attached Tribal Food Distribution Program |
| 17 | Budget Amendment #1, effective October 01, 2007 through September 30, 2008. The |
| 18 | budget amendment reflects the increase from \$74,760.71 to \$78,032.35 which is an |
| 19 | increase of \$3,271.80 of the tribal match requirement which is from the Nation's |
| 20 | surplus funding. The amendment incorporates changes for personnel and operational |
| 21 | line items, and adds new line items: Communication Expense, Supplies Office, |
| 22 | Supplies Other, and RM Building. The fund source for the additional \$3,271.80 is the |
| 23 | Tribal surplus funds. |
| 24 | BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice- |
| 25 | Chairman and any designated officials are hereby authorized to negotiate, expend |
| 26 | and execute Budget Amendment #1 as attached, provided however, that that any |
| 27 | amendments affecting the funds or funding levels shall be submitted for further prior |
| 28 | approval by the Tohono O'odham Legislative Council. |
