RESOLUTION NO. 08-449

1 **WHEREAS, the Tohono O'odham Nation through the Child Care & Development Fund has been**
2 **successfully providing services and assistance to eligible Tohono O'odham children**
3 **and families; and**

4 **WHEREAS, the CCDF Mandatory Program Budget FY08 Modification/Amendment #1, Account 11-**
5 **1231 has been reviewed and approved by the Human Resources Development**
6 **Committee and Budget and Finance Committee; and**

7 **WHEREAS, this Modification/Amendment #1 reflects an increase in line item 816 in the amount**
8 **of \$15,322.00, and a decrease in line items 650, 661, 721, 724, 771, 772, and 810 in the**
9 **amount of \$13,000.00 which reduces the Indirect Cost by \$2,322.00.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the Child Care & Development Fund Mandatory Program Budget FY 2008**
12 **Modification/Amendment #1 Account 11-1231 by increasing line item 816 in the**
13 **amount of \$15,322.00, and decreasing line items 650, 661, 721, 724, 771, 772, and 810**
14 **in the amount of \$13,000.00 which reduces the Indirect Cost by \$2,322.00.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Officials, to wit; the Chairperson and any official appointed designee is hereby**
17 **authorized to expend the budget provided however, that any amendment affecting the**
18 **funding or funding levels of this budget shall be submitted for further prior approval**
19 **by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH. Day**
21 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)(3)**
23 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**


