

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2008, Tohono O'odham Department of Health and Human Services,
Division of Community Health Service - Women Infants and Children (WIC) - ITCA,
Budget Modification and Amendment 1)

RESOLUTION NO. 08-452

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Tohono O'odham**
2 **Department of Health and Human Services, Division of Community Health, Women**
3 **Infants and Children (WIC) Program; and**

4 **WHEREAS, the Inter-Tribal Council of Arizona through an Intergovernmental Agreement receives**
5 **funds from the United States Department of Agriculture for programs designed to**
6 **benefit women, infants and children; and**

7 **WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with the**
8 **Inter-Tribal Council of Arizona to fund and operate the Women Infants and Children**
9 **(WIC) Program which commenced on October 01, 2002 through September 30, 2006,**
10 **which was approved through Resolution Number 02-439; and**

11 **WHEREAS, the WIC services provided to eligible clients have been beneficial and services**
12 **continue to be necessary to help alleviate nutritional health risks and improve the**
13 **health of individuals at risk; and**

14 **WHEREAS, the Inter Tribal Council of Arizona is increasing, effective April, 2008, the WIC Program**
15 **assigned caseload to 1050, and the grant level from \$161,100.01 to \$166,980.00, which**
16 **includes an Indirect Cost increase of \$2,976.13; and**

17 **WHEREAS, the Nutrition Specialist salary was incorrectly budgeted at \$29,939.14, and the correct**
18 **amount is \$30,687.63, the difference of \$748.49 is added to salaries, and likewise the**
19 **Fringe Benefits amount is increased by \$232.03; and**

20 **WHEREAS, funding increase is distributed among line item accounts, except for some line item**
21 **decreases, including the Professional Services line item which is reduced by**
22 **\$12,476.66.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby:**

- 24 **1. Approve and authorize expenditures of the attached FY 2008 WIC-ITCA Budget/**
25 **Amendment #1 that increases the budget by \$5,879.99 for a new total of**
26 **\$166,980.00.**
- 27 **2. Approves the salary and fringe benefits corrections.**
- 28 **3. Approves the Indirect Cost (IDC) rate increase of \$2,976.13 to the budget which**

changes the IDC from \$22,115.52 to a new total of \$25,091.65

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Official, to wit; the Chairman and Vice Chairman and any designated official are authorized to negotiate and execute the Memorandum of Agreement associated with this program, provided however, that any amendments affecting the funding or funding level of the Memorandum of Agreement shall be submitted for further approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


