13 **Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham**
14 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
15 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
16 **of the Act of June 18, 1934 (48 Stat. 984).**


