The Tohono O'odham Legislative Council hereby accepts and approves the 18 Certification of Eligible Members, in the form attached hereto. 19 2. The Tohono O'odham Legislative Council authorizes (a) the transfer of the sum of 20 \$92,000.00 from the Per Capita Account to the special checking account 21 established at Bank of America (the Per Capita Checking Account); and (b) upon 22 the authorized signature of the Nation, issuance of a check on the Per Capita 23 Checking Account in the amount of (I) \$2,000.00 to each Eligible Member residing 24 in the United States and listed in the attached Certification of Eligible Members, 25 and (ii) \$1,400.00 to each Eligible Member residing outside the United States and listed in the attached Certification, with the balance of \$600.00 withheld and 26 remitted to the Internal Revenue Service pursuant to the requirements of federal 27 28 law. 29 3. The Chairman of the Nation is authorized to execute such other documents as **30** may be necessary to implement this Resolution.
