

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Paul Andrew to the Election Board for a Five-Year Term)**

**RESOLUTION NO. 08-463**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint**  
2 **members of the Tohono O'odham Election Board pursuant to Section 1(B) of Article**  
3 **II of Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"),**  
4 **which states, "Members of the Election Board shall be appointed by the Tohono**  
5 **O'odham Council for terms of five years, or until their successors are appointed and**  
6 **qualified"; and**

7 **WHEREAS, the Election Ordinance further requires "that appointments to the board shall be**  
8 **made in such a way and for such terms that their terms shall be staggered so that the**  
9 **term of office of only one member will end in any single year."; and**

10 **WHEREAS, On September 9, 2003 Paul Andrew was appointed to the Election Board for a five-**  
11 **year term commencing August 1, 2003 by Resolution No. 03-397; and**

12 **WHEREAS, on July 31, 2008, Election Board Member Paul Andrew's term expired; and**

13 **WHEREAS, the Rules Committee recommends that Paul Andrew be reappointed to the Election**  
14 **Board for a five-year term.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **appoints Paul Andrew to a five-year term on the Election Board commencing August**  
17 **1, 2008 and ending July 31, 2013.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
19 **of AUGUST, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1 (g) and Article X, Section 7 of the Constitution of the Tohono O'Odham Nation,**  
22 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
23 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
24 **Act of June 18, 1934 (48 Stat. 984).**


