

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting August 15, 2008 Special Session to Address 12% Contributions Under the Tohono
O'odham Nation-State of Arizona Gaming Compact and Other Matters the Council Votes
to Add to the Agenda)**

LEGISLATIVE ORDER NO. 08-480

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures**
2 **to regulate all meetings of the Tohono O'odham Council, standing committees,**
3 **boards and special committees." (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**
6 **with the authority to "by majority vote, call for a special session" (Legislative Rules**
7 **of the Tohono O'odham Legislative Council, Article I, Section 1.D.2.); and**

8 **WHEREAS, the Legislative Council Commerce Committee has requested a special session for**
9 **August 15, 2008 to address the 12% contributions to cities, towns and counties under**
10 **the Tohono O'odham Nation-State of Arizona Gaming Compact and other matters**
11 **the Council votes to add to the agenda.**

12 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**
13 **special session on August 15, 2008 to address the 12% contributions to cities, towns**
14 **and counties under the Tohono O'odham Nation-State of Arizona Gaming Compact**
15 **and other matters the Council votes to add to the agenda.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH Day of**
17 **AUGUST, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
19 **Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
