5	WHEREAS, the Program will continue to provide intervention and prevention programs to assist
6	in the education and awareness of alcohol and substance abuse-related juvenile
7	crimes; and
8	WHEREAS, the Tohono O'odham Nation submitted and was approved a No Cost Extension for the
9	period of July 01, 2008 through June 30, 2009; via email from Project Officer, Ms. Kate
10	Winton, and an approved Grant Adjustment Notice (GAN) posted on July 10, 2008; and
11	WHEREAS, the unobligated balance ending FY July 01, 2007 – June 30, 2008 ending balance
12	amount of \$409,040.47 and this amount will be carried over for the budget beginning
13	July 01, 2008 through June 30, 2009.
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
15	approves the No Cost Extension on Grant Award No. 2005-AC-BX-0005 for the period of
16	July 01, 2008 – June 30, 2009.
17	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby approve and
18	authorizes the expenditures of the attached FY 2008-2009 budget for the Indian
19	Alcohol and Substance Abuse Program in the amount of \$409,040.47.
20	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
21	Chairman of the Nation to negotiate and execute the contracts and plans, provided,
22	however, that any amendments affecting the funding or funding levels of this contract
23	shall be submitted for further prior approval by this Council.
