

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Chukut Kuk District FY 2008 Budget Modification/Amendment No. 1)

RESOLUTION NO. 08-498

- 1 **WHEREAS, the Chukut Kuk District is an official recognized district of the Tohono O'odham**
2 **Nation pursuant to the Tohono O'odham Constitution, (1986); and**
- 3 **WHEREAS, no district council shall expend district funds except pursuant to budgets authorized**
4 **under resolution of the district council and approved by the Tohono O'odham**
5 **Legislative Council (T.O.N. Const. 1986); and**
- 6 **WHEREAS, on April 12, 2008, the Chukut Kuk District did have an official meeting in Vamori at**
7 **which a quorum was present; and**
- 8 **WHEREAS, the District did approve amendment to the Vamori Community FY 2008 Budget**
9 **justification to include payments for installation of security doors for elders (CKD Res.**
10 **2008-19); and**
- 11 **WHEREAS, on June 30, 2008 the Chukut Kuk District did have an official meeting in San Miguel at**
12 **which a quorum was present; and**
- 13 **WHEREAS, there were savings identified in the District FY 08 Salaries savings which was proposed**
14 **to be utilized to cover a wage compensation adjustment for district employees and**
15 **further to cover the increase of minimum wage increase for the youth workers and to**
16 **cover other over expenditures (CKD Res. 2008-27); and**
- 17 **WHEREAS, the Tecolote Community did request to move \$1,000 from the Youth Budget line item**
18 **to the Community Budget line item(CKD Res. 2008-27); and**
- 19 **WHEREAS, the ceiling amounts for the Student Stipends were increased (CKD Res. 2008-27); and**
- 20 **WHEREAS, on July 12, 2008 the Chukut Kuk District did have an official meeting in San Miguel at**
21 **which a quorum was present; and**
- 22 **WHEREAS, savings were identified in the District's FY 2007 Budget and it was approved to**
23 **reinstate the justification and funding for installation of a cattle guard for the Vamori**
24 **Community, (CKD Res. 2008-29); and**
- 25 **WHEREAS, the Chukut Kuk does have sufficient funding to cover all modifications and**
26 **amendments presented herein and attached hereto; and**
- 27 **WHEREAS, the proposed budget amendments and modifications have been reviewed by the**
28 **Tohono O'odham Legislative Council, Budget & Finance Committee.**
- 29 **NOW THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
30 **the Chukut Kuk District's FY 2008 Budget Modification/Amendment No. 1 as presented**

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the amendment to the Vamori Community FY 2008 Budget justification to include payments for installations of security doors for elders (As approved by CKD Res. 2008-19).

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the use of identified savings in the District FY 08 salaries savings which is approved to be utilized to cover a wage compensation adjustment due to inflation for district employees and further cover the increase of minimum wage increase for the youth workers and to cover other over expenditures (As approved by CKD Res. 2008-27);

- 1. \$30,163.92 will be utilized to cover a wage compensation adjustment from June 1, 2008 to September 30, 2008 for district employees and a minimum wage increase for youth workers.**
- 2. \$10,179.80 will be added to line item 660 – Travel to cover over expenditures and anticipated cost.**
- 3. \$640.00 will be added to line item 772 – Repair & Maintenance Building to cover anticipated cost.**
- 4. \$1,000.00 will be added to line item – Food to cover anticipated cost.**
- 5. \$5,000.00 will be added to line item 625 Student Stipend to amend the ceiling amounts as follows; Elementary at \$500.00, Junior High at \$800.00, High School at \$1,000.00 and Higher Education & Technical Training at \$1,500.00.**
- 6. \$15,340.35 will be added to line item 865 – Personal Emergencies to cover over expenditure and anticipated cost.**
- 7. \$1,000.00 will be moved from the Tecolote Youth line item to the Tecolote Community line item.**

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the amendment to line item 810 – Professional Services to add justification for construction of a new cattle guard for the Vamori Community, (As approved by CKD Res. 2008-29).

BE IT FINALLY RESOLVED that any amendments affecting the funding levels of the Chukut Kuk District budget shall be submitted for further prior approval by the Tohono O'odham Legislative Council.
