

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier District Budget for the Fiscal Year beginning on October 1, 2008
and ending September 30, 2009)

RESOLUTION NO. 08-521

1 **WHEREAS, on August 19, 2008 the Tohono O'odham Legislative Council's Budget and Finance**
2 **Committee reviewed the San Xavier District's projected expenditures for the fiscal**
3 **year ending on September 30, 2009; and**

4 **WHEREAS, the San Xavier District Council intends to utilize its gaming revenues and general**
5 **operating funds to meet the projected budget amount outlined in the attached fiscal**
6 **year 2009 budget; and**

7 **WHEREAS, the proposed budget of \$7,990,339.35 was reviewed and approved by majority vote of**
8 **the San Xavier District members present at the Special District Community meeting**
9 **held on August 9, 2008.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby with the**
11 **authority granted under the Tohono O'odham Constitution Article IX, Section 7**
12 **approves the San Xavier District's fiscal year 2009 budget in the amount of seven**
13 **million, nine hundred ninety thousand, three hundred thirty-nine dollars and thirty-**
14 **five cents.**

15 **BE IT FINALLY RESOLVED that the above total amount will be derived from two sources gaming**
16 **revenues in the amount fo \$7,912,640.93 and San Xavier District general operating**
17 **funds in the amount of \$77,689.42.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
19 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 1,038.15 FOR; \$71.8**
20 **AGAINST; 624.55 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
