

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Appropriation of Funds (\$18,576.00) to the Early Childhood/Head Start
Facilities FY 08 Budget)**

RESOLUTION NO. 08-523

1 **WHEREAS, pursuant to Resolution No. 04-653, the Legislative Council approved an appropriation**
2 **for the renovation and construction of Early Childhood/Headstart Centers; and**

3 **WHEREAS, the Planning Administration is requesting remaining funds in the amount of**
4 **\$18,576.00; for payment for two scoping meetings held in FY-08 for the proposed Early**
5 **Childhood Headstart Facilities renovation; and**

6 **WHEREAS, the Planning Administration is requesting an appropriation from the Construction**
7 **Investment Account in the amount of \$18,576.00 for FY-2008.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
9 **approve and authorize the appropriation in the amount of \$18,576.00 in accordance**
10 **with the Headstart/Child Care Centers Construction Budget effective July 31, 2008 thru**
11 **September 30, 2008 funds will appropriated and expended from budget line item 810**
12 **Professional Services.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairman and any designated official to expend and administer the budget as**
15 **attached provided that any amendments affecting the funds or funding levels shall**
16 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
18 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,362.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and 172.0[06] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**
