5	WHEREAS, this budget also provides for the maintenance and grounds keeping of the San Simon
6	Health Center and Dialysis Center buildings; and
7	WHEREAS, the Leasing Office will be a program under the Planning Department and the Planning
8	Administration is requesting approval of an appropriation for the FY-08 Budget in the
9	amount of \$509,014.33; and
10	WHEREAS, the funds not expended in FY-08 will be carried over for the FY-09 budget; and
11	WHEREAS, the Commerce Committee and Budget & Finance Committees have reviewed and
12	approved the Leasing Office budget as presented.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
14	the budget amount of \$509,014.33 and approves the attached budget in the amount of
15	\$509,014.33.
16	BE IT FURTHER RESOLVED that the appropriation for this budget is to be funded equally from the
17	Westside Health Housing Quarters investment account, where there are sufficient
18	funds available, in the amount of \$254,507.17, and from the Dialysis Supplemental
19	investment account, where there are sufficient funds available, in the amount of
20	\$254,507.17, for the total budget amount of \$509,014.33.
21	BE IT FURTHER RESOLVED the Tohono O'odham Legislative Council approves the FY 2009 Budget
22	to consist of all unexpended funds from FY 2008 Leasing Office Budget.
23	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Chairman,
24	Vice-Chairman and any designated official to expend and administer the budget as
25	attached, provided that any amendments affecting the funds or funding levels shall
26	be submitted for further prior approval by the Tohono O'odham Legislative Council.
