

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving 2008/2009 "100 Communities Grant" budget)**

RESOLUTION NO. 08-526

1 WHEREAS, the "100 Communities" grant opportunity was made possible through the Corporation  
2 for National and Community Service (CNCS) the Administration for Native Americans  
3 (ANA) and the National Society for American Indian Elderly (NSAIE); and

4 WHEREAS, the purpose of the grants is to fund community outreach effort that address abuse  
5 issues to include, drug use and abuse, alcohol misuse and abuse, domestic violence,  
6 elder abuse (includes financial abuse, physical abuse or emotional abuse) and suicide  
7 prevention; and

8 WHEREAS, the Tohono O'odham Nation Division of Senior Services submitted an application for  
9 the grant and was awarded \$1,000.00; and

10 WHEREAS, the Division of Senior Services developed the attached plan to address one of the root  
11 cause of elder abuse, the breakdown in the intergenerational relationship, in  
12 accordance with the objectives of the campaign.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
14 accepts the grant award and approves:

- 15 1. The FY 2008/2009 "100 Communities" grant budget in the amount of \$1,000.
- 16 2. The Division of Senior Services to engage in a grassroots approach to address one  
17 of the root cause of elder abuse, the breakdown in the intergenerational  
18 relationship plan as attached.

19 BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman and Vice  
20 Chairman are hereby authorized to negotiate and execute the grant, provided  
21 however, that any amendment affecting the funding or funding levels of this contact  
22 shall be submitted for further approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day  
24 of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
25 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section  
26 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
27 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
29 Stat. 984).
