


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating \$15,000 from the Tohono O'odham Nation Surplus Funds to
Support the Walk Home)**

RESOLUTION NO. 08-530

- 1 **WHEREAS, the Walk Home is a 3000 mile journey to promote Native wellness; and**
2 **WHEREAS, during this walk, five members of the Tohono O'odham Nation will spend the next year**
3 **walking 3000 miles throughout Indian Country to bring awareness of both the**
4 **challenges of Type 2 Diabetes and the power our communities have to take control of**
5 **our own wellness; and**
6 **WHEREAS, the Walk Home will inspire action for wellness in our own Tohono O'odham**
7 **community and Native communities across the country; and**
8 **WHEREAS, the Tohono O'odham Nation supports efforts to promote wellness and inspire people**
9 **to improve their health; and**
10 **WHEREAS, the total costs of the Walk Home will exceed \$100,000; and**
11 **WHEREAS, the Tohono O'odham Nation Executive Office has informed TOCA surplus funds are**
12 **available for FY 2008; and**
13 **WHEREAS, the Tohono O'odham Nation Executive Office has informed TOCA that it supports the**
14 **use of \$15,000 of these surplus funds to support the Walk Home.**
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council approve**
16 **a total of \$15,000 (\$3000 for each Tohono O'odham walker) from the Tohono O'odham**
17 **Nation surplus funds in financial support for the Walk Home.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 1,849.65 FOR;**
20 **415.65 AGAINST; 97.2 NOT VOTING; and 172.0 [07] ABSENT, pursuant to the powers vested in the**
21 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
22 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
