

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Mr. Jonathan Jantzen as Attorney General of the  
Tohono O'odham Nation)**

**RESOLUTION NO. 08-534**

1 **WHEREAS, the "Statute Creating the Office of Attorney General of the Tohono O'odham Nation,"**  
2 **was adopted on October 1, 1989 by Resolution No. 326-89, and was amended on**  
3 **November 6, 1991 by Resolution No. 91-500. (OAG Statute); and**

4 **WHEREAS, the OAG Statute provides in part, that the Attorney General shall be appointed by the**  
5 **Chairman of the Nation, from among a group of no fewer than three persons qualified**  
6 **for the position, nominated by the Domestic Affairs Committee of the Legislative**  
7 **Council. The appointment shall become effective upon its approval by a majority of**  
8 **the Legislative Council; and**

9 **WHEREAS, On May 13, 2008 the Domestic Affairs Committee forwarded the names of four persons**  
10 **qualified for the position of Attorney General to the Chairman of the Nation; and**

11 **WHEREAS, the Chairman of the Tohono O'odham Nation, interviewed the candidates and selected**  
12 **Mr. Jonathan Jantzen as the appointee for Attorney General of the Tohono O'odham**  
13 **Nation; and**

14 **WHEREAS, Mr. Jonathan Jantzen is qualified to assume the position of Attorney General; and**

15 **WHEREAS, Mr. Jonathan Jantzen has accepted the appointment and the position upon approval**  
16 **of the Tohono O'odham Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
18 **the appointment of Mr. Jonathan Jantzen as Attorney General of the Tohono O'odham**  
19 **Nation to serve in accordance with the Statute Creating the Office of Attorney General.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>. Day**  
21 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**  
22 **AGAINST; 181.1 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (b) and 2 (e) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
24 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**




