9	months per child (\$75.00 monthly stipend per child x 6 months = \$450.00 x 300
10	children = \$13,500.00.
11	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby:
12	1. Approves and accepts the Grandparent Kinship Care Program budget in the
13	amount of \$13,500.00 to be retroactive to July 1, 2008 through June 30, 2009.
14	2. That the Kinship Care FY 2009 budget in the amount of \$13,500.00 be used to
15	provide financial support to Elders who are raising grandchildren as follows:
16	\$75.00 monthly stipend to grandparents raising grandchildren for up to a period of 6
17	months per child (\$75.00 monthly stipend per child x 6 months = \$450.00 x 300
18	children = \$13,500.00).
19	BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman and Vice
20	Chairman are hereby authorized to negotiate and execute the grant, provided
21	however, that any amendment affecting the funding or funding levels of this contract
