

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY2009 Kinship Care Program Budget Under the Older Americans Act,**  
**Title III July 1, 2008 to June 30, 2009)**

RESOLUTION NO. 08-535

1 **WHEREAS, the State of Arizona appropriated funding through the Inter-Tribal Council of Arizona,**  
2 **Region 8 Administration on Aging for Kinship Care; and**

3 **WHEREAS, the Tohono O'odham Nation Division of Senior Services was awarded \$13,500.00 for**  
4 **the Grandparent Kinship Care Program under the Older Americans Act (OAA), Title III**  
5 **for the period of July 1, 2008 through June 30, 2009; and**

6 **WHEREAS, Grandparent Kinship Care Program funds will be used to provide financial support**  
7 **to Elders who are raising grandchildren as follows:**

8 **\$75.00 monthly stipend to grandparents raising grandchildren for up to a period of 6**  
9 **months per child (\$75.00 monthly stipend per child x 6 months = \$450.00 x 300**  
10 **children = \$13,500.00.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby:**

12 **1. Approves and accepts the Grandparent Kinship Care Program budget in the**  
13 **amount of \$13,500.00 to be retroactive to July 1, 2008 through June 30, 2009.**

14 **2. That the Kinship Care FY 2009 budget in the amount of \$13,500.00 be used to**  
15 **provide financial support to Elders who are raising grandchildren as follows:**  
16 **\$75.00 monthly stipend to grandparents raising grandchildren for up to a period of 6**  
17 **months per child (\$75.00 monthly stipend per child x 6 months = \$450.00 x 300**  
18 **children = \$13,500.00).**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman and Vice**  
20 **Chairman are hereby authorized to negotiate and execute the grant, provided**  
21 **however, that any amendment affecting the funding or funding levels of this contract**  
22 **shall be submitted for further approval by this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
24 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section**  
26 **1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**
