

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Carry-Over appropriation in the amount of \$135,549.85 for FY 2009
General Support Services – Motor Pool Budget Amendment No. 1)

RESOLUTION NO. 08-543

1 **WHEREAS, the Tohono O'odham Legislative Council approved a supplemental proposal for each**
2 **of the Nations General Support Services including the Nations Motor Pool (Resolution**
3 **No. 08-073); and**

4 **WHEREAS, Resolution No. 08-073 provides for consideration of approval specific carry over**
5 **amount for the purpose of the initial appropriation; and**

6 **WHEREAS, the Nations Motor Pool submits for review and approval the attached FY 2009 Budget**
7 **Amendment Number 1; and**

8 **WHEREAS, the budget is amended to add line item 750 Major Capital Equipment in the amount**
9 **of \$135,549.85, which is the unexpended amount from the FY 2008 Motor Pool Budget,**
10 **for the purpose of completion of the construction of a secured parking yard and the**
11 **upgrade of the current fuel system with additional fuel sites; and**

12 **WHEREAS, Fiscal Year 2009 Budget Amendment No. 1 for the Nations Motor Pool has been**
13 **reviewed by the Legislative Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves the**
15 **Carry-Over amount of \$135,549.85 that is the unexpended funds from the FY 2008**
16 **Motor Pool Budget.**

17 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**
18 **Nations Motor Pool FY 2009 Budget Amendment Number 1 to add line item 750 Major**
19 **Capital Equipment in the amount of \$135,549.85 for the purpose of completion of the**
20 **construction of a secured parking yard and the upgrade of the current fuel system**
21 **with additional fuel sites.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
24 **authorized to administer the FY2009 Motor Pool Budget, provided however, that any**
25 **amendments affecting the funds or funding levels of the budget shall be submitted for**
26 **further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
28 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and 02] ABSENT, pursuant to the powers vested in the Council by Section**
30 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
