

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Carry-Over appropriation in the amount of \$230,000.00 for FY 2009
General Support Services – Human Resources Office Amendment No. 1)

RESOLUTION NO. 08-544

1 **WHEREAS, the Tohono O'odham Legislative Council approved a supplemental proposal for each**
2 **of the Nations General Support Services including the Human Resources Office**
3 **(Resolution No. 08-080); and**

4 **WHEREAS, Resolution No. 08-080 provides for consideration of approval carry over amount for**
5 **the purpose of the initial appropriation; and**

6 **WHEREAS, the Human Resources Office submits for review and approval the attached FY 2009**
7 **Budget Amendment Number 1; and**

8 **WHEREAS, the budget is amended to add line item 810 Professional Services in the amount of**
9 **\$230,000.00 for the purpose of continuing and completing the Tohono O'odham**
10 **Nation's Wage Compensation Study, and**

11 **WHEREAS, Fiscal Year 2009 Budget Amendment No. 1 for the Human Resources Office has been**
12 **reviewed by the Legislative Human Resources Development Committee and the**
13 **Legislative Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves the**
15 **Carry-Over amount of \$230,000.00 that is the unexpended funds from the FY 2008**
16 **Human Resources Office Budget.**

17 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**
18 **Human Resources Office FY 2009 Amendment Number 1 to add line item 810**
19 **Professional Services in the amount of \$230,000.00 for the purpose of continuing and**
20 **completing the Tohono O'odham Nation's Wage Compensation Study.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
23 **authorized to administer the FY2009 Human Resources Office, provided however, that**
24 **any amendments affecting the funds or funding levels of the budget shall be submitted**
25 **for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
27 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**
29 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
