

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving a Carry-Over appropriation in the amount of \$1,208,788.05 for FY 2009**  
**General Support Services – Facility Management Budget Amendment No. 1)**

**RESOLUTION NO. 08-545**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a supplemental proposal for each**  
2 **of the Nations General Support Services including the Nations Facility Management**  
3 **(Resolution No. 08-081); and**

4 **WHEREAS, Resolution No. 08-081 provides for consideration of approval specific carry over**  
5 **amount for the purpose of the initial appropriation; and**

6 **WHEREAS, the Nations Facility Management submits for review and approval the attached FY**  
7 **2009 Budget Amendment Number 1; and**

8 **WHEREAS, the budget is amended to add line item 778 Alteration/Renovation and increase line**  
9 **items 650,660,712,720,721,722,723,730,770,771 and 772 for a total amount of**  
10 **\$1,208,788.05 for the purpose of completion of the alteration and renovation of the**  
11 **Facility Management and to complete expenditures from the initial surplus**  
12 **appropriation; and**

13 **WHEREAS, Fiscal Year 2009 Budget Amendment No. 1 for the Nations Facility Management has**  
14 **been reviewed by the Legislative Budget and Finance Committee.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves the**  
16 **Carry-Over amount of \$1,208,788.05 that is the unexpended funds from the FY 2008**  
17 **Facility Management Budget.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**  
19 **Nations Facility Management FY 2009 Budget Amendment Number 1 to add line item**  
20 **778 Alteration/Renovation and increase line items 650,660,712,720,721,**  
21 **722,723,730,770,771 and 772 for a total amount of \$1,208,788.05 for the purpose of**  
22 **completion of the alteration and renovation of the Facility Management and to**  
23 **complete expenditures from the initial surplus appropriation.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**  
26 **authorized to administer the FY2009 Facility Management Budget, provided however,**  
27 **that any amendments affecting the funds or funding levels of the budget shall be**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


