

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Carry-Over appropriation in the amount of \$179,546.95 for FY 2009
General Support Services - Department of Information & Technology Amendment No. 1)

RESOLUTION NO. 08-546

1 **WHEREAS, the Tohono O'odham Legislative Council approved a supplemental proposal for each**
2 **of the Nations General Support Services including the Nations Department of**
3 **Information & Technology (Resolution No. 08-079); and**

4 **WHEREAS, Resolution No. 08-079 provides for consideration of approval specific carry over**
5 **amount for the purpose of the initial appropriation; and**

6 **WHEREAS, the Nations Department of Information & Technology submits for review and**
7 **approval the attached FY 2009 Budget Amendment Number 1; and**

8 **WHEREAS, the budget is amended to add line items 750 Major Capital for the upgrade of the**
9 **Nations phone system and increase line item 774 Computer Maintenance for the**
10 **upgrade of the wireless infrastructure and email system for a total amount of**
11 **\$179,546.95; and**

12 **WHEREAS, Fiscal Year 2009 Budget Amendment No. 1 for the Nations Department of Information**
13 **& Technology has been reviewed by the Legislative Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves the**
15 **Carry-Over amount of \$179,546.95 that is the unexpended funds from the FY 2008**
16 **Department of Information & Technology Budget.**

17 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**
18 **Nations Department of Information & Technology FY 2009 Budget Amendment**
19 **Number 1 to add line items 750 Major Capital for the upgrade of the Nations phone**
20 **system and increase line item 774 Computer Maintenance for the upgrade of the**
21 **wireless infrastructure and email system for a total amount of \$179,546.95.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
24 **authorized to administer the FY2009 Department of Information & Technology**
25 **provided however, that any amendments affecting the funds or funding levels of the**
26 **budget shall be submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
29 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section**
31 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
