

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Appropriating the FY 2009 Supplemental Budget for the Department  
of Health & Human Services-Division of Special Needs in the amount of \$269,666.73)**

**RESOLUTION NO. 08-548**

1 **WHEREAS, at the direction of the Chairman and Vice Chairman of the Nation the Department of**  
2 **Health & Human Services-Division of Special Needs has submitted a budget for**  
3 **supplemental funding which will increase the overall FY-09 budget in salaries and**  
4 **operations; and**

5 **WHEREAS, the Department of Health & Human Services-Division of Special Needs is a key**  
6 **department which has identified the lack of program staff and reliable program**  
7 **vehicles as a major challenge in providing consistent service to individuals and their**  
8 **families leaving many underserved or unserved. Thus, many individuals face**  
9 **challenges in their efforts to obtain appropriate services and supports without**  
10 **assistance from this Division; and**

11 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to the**  
12 **Department of Health & Human Services-Division of Special Needs to improve the**  
13 **overall department and delivery of service for our Nations members; and**

14 **WHEREAS, the attached supplemental budget in the amount of \$269,666.73 of which \$135,000.00**  
15 **of the total is a one-time appropriation and \$134,666.73 is recurring, was presented**  
16 **to and reviewed by the Health & Human Services Oversight Committee and Budget &**  
17 **Finance Committees of the Tohono O'odham Legislative Council; and**

18 **WHEREAS, the amount of \$134,666.73 will be integrated into the FY-09 Department of Health &**  
19 **Human Services-Division of Special Needs base budget.**

20 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
21 **the attached supplemental budget for FY-2009 in the amount of \$269,666.73 for the**  
22 **Department of Health & Human Services-Division of Special Needs to be effective**  
23 **October 1, 2008.**

24 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Department of Health & Human**  
25 **Services-Division of Special Needs supplemental budget attached hereto in the**  
26 **amount of \$134,666.73 shall be integrated into the base budget and shall be recurring**  
27 **for future fiscal years.**

28 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Department of Health & Human**  
29 **Services-Division of Special Needs supplemental budget attached hereto in the**  
30 **amount of \$135,000.00 shall be for a one-time appropriation to be expended within**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
