

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2009 Supplemental Budget for the Department of Natural Resources, Solid Waste Management Program in the amount of \$1,405,634.77)

RESOLUTION NO. 08-549

1 **WHEREAS, at the direction of the Chairman and Vice Chairman of the Nation the Department of**
2 **Natural Resources, Solid Waste Management Program has submitted a budget for**
3 **supplemental funding which will increase the overall FY-09 budget in salaries and**
4 **operations; and**

5 **WHEREAS, the Department of Natural Resources, Solid Waste Management Program is a key**
6 **department whose responsibilities have increased over time to clean up illegal**
7 **migrant waste and whose equipment is aging due to high mileage and rough roads;**
8 **and**

9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to the**
10 **Department of Natural Resources, Solid Waste Management Program to improve the**
11 **overall department and delivery of service for our Nations members; and**

12 **WHEREAS, the attached supplemental budget in the amount of \$1,405,634.77 of which**
13 **\$1,248,000.00 of the total is a one-time appropriation and \$157,634.77 is recurring, was**
14 **presented to and reviewed by the Natural Resources and Budget & Finance**
15 **Committees of the Tohono O'odham Legislative Council; and**

16 **WHEREAS, the amount of \$157,634.77 will be integrated into the FY-09 Department of Natural**
17 **Resources, Solid Waste Management Program base budget.**

18 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**
19 **the attached supplemental budget for FY-2009 in the amount of \$1,405,634.77 from the**
20 **FY 2008 General Revenue Surplus and FY 2009 General Revenue Projection for the**
21 **Department of Natural Resources, Solid Waste Management Program to be effective**
22 **October 1, 2008.**

23 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Department of Natural Resources,**
24 **Solid Waste Management Program supplemental budget attached hereto in the**
25 **amount of \$157,634.77 from the FY 2009 General Revenue Projection shall be**
26 **integrated into the base budget and shall be recurring for future fiscal years.**

27 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Department of Natural Resources,**
28 **Solid Waste Management Program supplemental budget attached hereto in the**
29 **amount of \$1,248,000.00 from the FY 2008 General Revenue Surplus shall be for a one-**
30 **time appropriation to be expended within the FY 2009 fiscal year.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
32 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
33 **administer the attached budget, provided, however that any amendments affecting**
34 **these funds or funding levels that are budgeted shall be submitted for prior approval**
35 **by the Tohono O'odham Legislative Council.**
