

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Appropriating the FY 2009 Supplemental Budget for the Department**  
**of Natural Resources, Tribal Herd in the amount of \$79,000.00)**

RESOLUTION NO. 08-550

1 **WHEREAS, at the direction of the Chairman and Vice Chairman of the Nation the Department of**  
2 **Natural Resources, Tribal Herd has submitted a budget for supplemental funding**  
3 **which will increase the overall FY-09 budget in operations; and**

4 **WHEREAS, the Department of Natural Resources, Tribal Herd is a key program and produces the**  
5 **Nation's cattle for sale, and will develop a water distribution system, and repair**  
6 **fences; and**

7 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to the**  
8 **Department of Natural Resources, Tribal Herd to improve the overall department and**  
9 **delivery of service for our Nations members; and**

10 **WHEREAS, the attached supplemental budget in the amount of \$ 79,000.00 of which \$79,000.00 of**  
11 **the total is a one-time appropriation and was presented to and reviewed by the**  
12 **Agricultural Committee and Budget & Finance Committees of the Tohono O'odham**  
13 **Legislative Council; and**

14 **WHEREAS, the amount of \$79,000.00 will be integrated into the FY-09 Department of Natural**  
15 **Resources, Tribal Herd base budget.**

16 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
17 **the attached supplemental budget for FY-2009 in the amount of \$79,000.00 from the**  
18 **FY 2008 General Revenue Surplus for the Department of Natural Resources, Tribal**  
19 **Herd to be effective October 1, 2008.**

20 **BE IT FURTHER RESOLVED that in accordance with the FY-09 the Department of Natural**  
21 **Resources, Tribal Herd supplemental budget attached hereto in the amount of**  
22 **\$79,000.00 shall be for a one-time appropriation to be expended within the FY 2009**  
23 **fiscal year.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**  
26 **administer the attached budget, provided, however that any amendments affecting**  
27 **these funds or funding levels that are budgeted shall be submitted for prior approval**  
28 **by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day**  
30 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,311.55 FOR; 90.55**  
31 **AGAINST; 132.40 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
32 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
33 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat. 984).**
