11		the total is a one-time appropriation and was presented to and reviewed by the
12		Agricultural Committee and Budget & Finance Committees of the Tohono O'odham
13		Legislative Council; and
14	WHEREAS,	the amount of \$79,000.00 will be integrated into the FY-09 Department of Natural
15		Resources, Tribal Herd base budget.
16	NOW, THEF	REFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves
17		the attached supplemental budget for FY-2009 in the amount of \$79,000.00 from the
18		FY 2008 General Revenue Surplus for the Department of Natural Resources, Tribal
19		Herd to be effective October 1, 2008.

21		Resources, Tribal Herd supplemental budget attached hereto in the amount of
