

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Appropriating the FY 2009 Supplemental Budget for the Planning  
Department Administration in the amount of \$700,000.00)**

**RESOLUTION NO. 08-552**

1 **WHEREAS, at the direction of the Chairman and Vice Chairman of the Nation the Planning**  
2 **Department Administration has submitted a budget for supplemental funding which**  
3 **will increase the overall FY-09 budget in salaries and operations; and**

4 **WHEREAS, the Planning Department Administration is a key department in developing the**  
5 **overall Nation's infrastructure by providing technical assistance, project**  
6 **management and other services, and where the department will be the primary**  
7 **source of information and advice about the comprehensive direction for the growth,**  
8 **conservation and redevelopment of all physical and economic aspects of the Nation;**  
9 **and**

10 **WHEREAS, the Nation's leaders have determined it necessary to provide added resources to the**  
11 **Planning Department Administration to improve the overall department and delivery**  
12 **of service for our Nation's members; and**

13 **WHEREAS, the attached supplemental budget in the amount of \$700,000.00 of which \$100,000.00**  
14 **of the total is a one-time appropriation and \$600,000.00 is recurring, was presented**  
15 **to and reviewed by the Commerce and Budget & Finance Committees of the Tohono**  
16 **O'odham Legislative Council; and**

17 **WHEREAS, the amount of \$600,000.00 will be integrated into the FY-09 Planning Department**  
18 **Administration base budget.**

19 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
20 **the attached supplemental budget for FY-2009 in the amount of \$700,000.00 from the**  
21 **FY 2008 General Revenue Surplus and FY 2009 General Revenue Projection for the**  
22 **Planning Department Administration to be effective October 1, 2008.**

23 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Planning Department**  
24 **Administration supplemental budget attached hereto in the amount of \$600,000.00**  
25 **from the FY 2009 General Revenue Projection shall be integrated into the base budget**  
26 **and shall be recurring for future fiscal years.**

27 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Planning Department**  
28 **Administration supplemental budget attached hereto in the amount of \$100,000.00**  
29 **shall be for a one-time appropriation from the FY 2008 General Revenue Surplus to**  
30 **be expended within the FY 2009 fiscal year.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
32 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**  
33 **administer the attached budget, provided, however that any amendments affecting**  
34 **these funds or funding levels that are budgeted shall be submitted for prior approval**  
35 **by the Tohono O'odham Legislative Council.**
