

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Appropriating the FY 2009 Supplemental Budget for the Gaming**  
**Office in the amount of \$799,423.05)**

**RESOLUTION NO. 08-554**

1 **WHEREAS, at the direction of the Chairman and Vice Chairman of the Nation the Gaming Office**  
2 **has submitted a budget for supplemental funding which will increase the overall FY-09**  
3 **budget in salaries and operations; and**

4 **WHEREAS, the Gaming Office is a key department to regulate gaming on the Tohono O'odham**  
5 **Nation and with expansion of gaming activities through additional transfer**  
6 **agreements and increases in Tohono O'odham Gaming Enterprise personnel and**  
7 **activities, it has become imperative to increase staff, operational and major capital**  
8 **equipment expense line items to carry out the Gaming Office regulatory functions; and**

9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to the**  
10 **Gaming Office to improve the overall department and delivery of service for our**  
11 **Nations members; and**

12 **WHEREAS, the attached supplemental budget, in the amount of \$799,423.05, \$248,000.00 of which**  
13 **is a one-time appropriation and \$551,423.05 is recurring, was presented to and**  
14 **reviewed by the Commerce and Budget & Finance Committees of the Tohono O'odham**  
15 **Legislative Council; and**

16 **WHEREAS, the amount of \$551,423.05 will be integrated into the FY-09 Gaming Office base budget.**

17 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
18 **the attached supplemental budget for FY-2009 in the amount of \$799,423.05 from the**  
19 **FY 2008 General Revenue Surplus and FY 2009 General Revenue Projection for the**  
20 **Gaming Office to be effective October 1, 2008.**

21 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Gaming Office supplemental budget**  
22 **attached hereto in the amount of \$551,423.05 from the FY 2009 General Revenue**  
23 **Projection shall be integrated into the base budget and shall be recurring for future**  
24 **fiscal years.**

25 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Gaming Office supplemental budget**  
26 **attached hereto in the amount of \$248,000.00 from the FY 2008 General Revenue**  
27 **Surplus shall be for a one-time appropriation to be expended within the FY 2009 fiscal**  
28 **year.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
30 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**  
31 **administer the attached budget, provided, however that any amendments affecting**  
32 **these funds or funding levels that are budgeted shall be submitted for prior approval**  
33 **by the Tohono O'odham Legislative Council.**
