

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Appropriating the FY 2009 Supplemental Budget for the Office  
of the Chairman in the amount of \$110,868.30)**

**RESOLUTION NO. 08-556**

1 **WHEREAS, the Office of the Chairman provides legal review and support of all contracts to each**  
2 **of the Nations Departments, Programs, & Offices; and**

3 **WHEREAS, within the past ten years the Nations tribal government and services has grown**  
4 **immensely that include an increase in personnel, offices, buildings, vehicles and**  
5 **equipment and contracts negotiated; and**

6 **WHEREAS, the Nations leaders have determined it necessary to provide added resources in order**  
7 **to ensure that our government's infrastructure is secure to provide optimum services**  
8 **for all of the Nations Departments and Programs.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves the**  
10 **attached supplemental budget for FY2009 in the amount of \$110,868.30 from the FY**  
11 **2009 General Revenue Projection for the Office of the Chairman in the total amount**  
12 **of \$ 110,868.30.**

13 **BE IT FURTHER RESOLVED that line items 610,620 and 721 in the amount of \$110,868.30 shall be**  
14 **a reoccurring appropriations for future fiscal years and does hereby add to the FY**  
15 **2009 Office of the Chairman.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
17 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**  
18 **administer the attached budget, provided, however that any amendments affecting**  
19 **theses funds or funding levels that are budgeted shall be submitted for prior approval**  
20 **by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
22 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 1,476.6 FOR; 598.0**  
23 **AGAINST; 459.9 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
