1	$\textbf{WHEREAS}, \ \textbf{the Tohono O'odham Legislative Council approved and adopted the recommendations}$
2	of the Human Resources Office resulting from the Valliant Study by Resolution 01-179;
3	and
4	WHEREAS, certain position classifications were capped at 20% therefore not receiving the full
5	salary recommended by the Valliant Study and subsequently approved by the
6	Legislative Council; and
7	WHEREAS, the 20% capped salaries for certain position classifications resulted in not receiving
8	the full market adjustments as approved by the Tohono O'odham Legislative Council
9	by Resolution 01-179.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
11	of Un-Capping the 20% Capped salaries imposed on certain positions in FY 2002.
12	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby appropriates
13	\$582,018.52 to uncap positions thereby resulting in full implementation of the Valliant
14	Study as approved by Resolution 01-179.
15	BE IT FINALLY RESOLVED that the funds of \$582,018.52 shall be appropriated from the FY 2009
16	General Revenue Projection.
17	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23 <sup>RD</sup> . Day
18	of <u>SEPTEMBER</u> , 2008 at a meeting at which a quorum was present with a vote of <u>2,211.95</u> FOR; <u>90.55</u>
19 20	AGAINST; <u>232.0</u> NOT VOTING; and <u>[03]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the

22	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
