

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating \$25,000.00 for the Tohono O'odham Nation Membership
Dues to the National Congress of American Indians)

RESOLUTION NO. 08-560

1 WHEREAS, the National Congress of American Indians (NCAI) has scheduled its 65th Annual
2 Session in Phoenix, Arizona on October 19-24, 2008; and

3 WHEREAS, the Tohono O'odham Nation is a longtime member in good standing with the NCAI; and

4 WHEREAS, it is in the best interest of the Tohono O'odham Nation to review its annual
5 membership with the NCAI; and

6 WHEREAS, NCAI 2008-2009 Tribal Membership Credential Process includes payment of
7 membership dues in accordance with its Constitution and By-Laws that include the
8 following payment schedule (NCAI Const. & By-Laws Article III, Sec.C.2):

<u>Income</u>	<u>Dues</u>
\$30 million or over	\$25,000.00
\$20 million to \$30 million	\$15,000.00
\$10 million to \$20 million	\$10,000.00
\$5 million to \$10 million	\$ 5,500.00
\$1 million to \$5 million	\$ 1,100.00
\$500,000 to \$1million	\$ 550.00
\$0.00 to \$500,000	\$ 110.00

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
18 and appropriates \$25,000.00 for payment of annual membership dues to the National
19 Congress of American Indians.

20 BE IT FINALLY RESOLVED that the funds of \$25,000.00 shall be appropriated from the FY 2008
21 General Revenue Surplus.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day
23 of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
24 AGAINST;-0-NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Section
25 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).


