9	request to share a \$50,000 sponsorship of the Youth Track agenda at NCAI; and						
10	WHEREAS, the Tohono O'odham Nation supports the activities of our youth with NCAI.						
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves						
12	and appropriates \$12,500.00 for co-sponsorship of the Youth Track for the National						
13	Congress of American Indians convention scheduled for October 19-24, 2008 in
