RESOLUTION NO. 08-564

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to consult with the**
2 **federal government and other Indian tribes on all matters within the Council's**
3 **authority (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

4 **WHEREAS, the National Congress of American Indians ("NCAI") will hold its 2008 65th Annual**
5 **Session in Phoenix, Arizona from October 19-24, 2008; and**

6 **WHEREAS, the Tohono O'odham Nation has worked closely with the NCAI and with Indian tribes**
7 **across the United States to address numerous national issues of importance to Indian**
8 **people; and**

9 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to continue its national-level**
10 **involvement in these issues by participating in the NCAI 2008 Annual Session.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
