

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2009 Supplemental Budget for the Membership Services and the Hia-Ced O'odham Program in the amount of \$52,226.35)**

RESOLUTION NO. 08-566

- 1 **WHEREAS, at the direction of the Chairman and Vice Chairman of the Nation the Membership**
2 **Services and Hia-Ced O'odham Program has submitted a budget for supplemental**
3 **funding which will increase the overall FY-09 budget in operations; and**
- 4 **WHEREAS, the Membership Services and Hia-Ced O'odham Program is a key program. The**
5 **Program has been without vehicle transportation since October 2007 and the program**
6 **has to borrow vehicles from other programs in the department or use personal**
7 **vehicles to take care of daily activities and to attend meetings on and off the Nation.**
8 **In addition we are in need of new computer equipment and desktop printers for the**
9 **program. The equipment is obsolete and constantly in need of maintenance. The cost**
10 **for computers and printers is \$4,726.35; and**
- 11 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to the**
12 **Membership Services Department and Hia-Ced O'odham Program to improve the**
13 **overall department and delivery of service for our Nations members; and**
- 14 **WHEREAS, the attached supplemental budget in the amount of \$52,226.35 was presented to and**
15 **reviewed by the Domestic Affairs Committee and Budget & Finance Committees of the**
16 **Tohono O'odham Legislative Council; and**
- 17 **WHEREAS, the amount of \$52,226.35 will be integrated into the FY-09 Membership Services**
18 **Department and Hia-Ced O'odham Program base budget.**
- 19 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**
20 **the attached supplemental budget for FY-2009 in the amount of \$52,226.35 from the**
21 **FY 2009 General Revenue Surplus for the Membership Services Department and Hia-**
22 **Ced O'odham Program to be effective October 1, 2008.**
- 23 **BE IT FURTHER RESOLVED that in accordance with the FY-09 the Membership Services and Hia-**
24 **Ced O'odham Program supplemental budget attached hereto in the amount of**
25 **\$52,226.35 from the FY 2008 General Revenue Surplus shall be for a one-time**
26 **appropriation to be expended within the FY 2009 fiscal year.**
- 27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
29 **administer the attached budget, provided, however that any amendments affecting**

1 **these funds or funding levels that are budgeted shall be submitted for prior approval**
2 **by the Tohono O'odham Legislative Council.**

3 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
4 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,159.0 FOR; 375.5**
5 **AGAINST; 0-NOT VOTING; and 107 ABSENT, pursuant to the powers vested in the Council by Section**
6 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
7 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
8 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
9 **Stat. 984).**
