

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Gu Achi District's Fiscal Year 2009 Budget of \$1,707,656.42)**

**RESOLUTION NO. 08-568**

1 **WHEREAS, the Tohono O'odham Legislative Council convened for its scheduled Special Session**  
2 **on September 23, 2008; and**

3 **WHEREAS, the Tohono O'odham Nation Legislative Council approved Resolution #08-490**  
4 **"Approving FY 2009 District Allocation and Apportionment of Gaming Revenues to**  
5 **Districts by Equal Distribution"; and**

6 **WHEREAS, the Gu Achi District's allocation is in the amount of \$1,707,656.42 for Fiscal Year 2009;**  
7 **and**

8 **WHEREAS, the Gu Achi District Council passed Resolution #0908-270 for approval of the Fiscal**  
9 **Year 2009 Budgets for the District's Administration and Communities for operational**  
10 **and direct services to meet the needs of the District and Communities; and**

11 **WHEREAS, the Gu Achi District Fiscal Year 2009 budget was presented, reviewed and**  
12 **recommended for approval by the Nation's Budget & Finance Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council hereby**  
14 **approves the Gu Achi District's Fiscal Year 2009 Budget in the amount of \$1,707,656.42**  
15 **as attached hereto.**

16 **BE IT FURTHER RESOLVED that the Gu Achi District Council approved by Resolution (#0708-236)**  
17 **directing for \$52,656.42 to be deposited into the District's Savings account.**

18 **BE IT FURTHER RESOLVED that any additional funds coming to the Gu Achi District will**  
19 **automatically be deposited to the District's Savings Account.**

20 **BE IT FINALLY RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**  
21 **Year 2009 budget in accordance with protocols set forth by this Council. Any**  
22 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**  
23 **2009 budget shall be approved by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup>, Day**  
25 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
27 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
