Communities, Artesia/Little Tucson, Choulic, Coldfields, Fresno Canyon, South
Komelic and Topawa)**

- 1 **WHEREAS, at a "special session" of the Tohono O'odham Legislative Council, held in the month**
 2 **of September 2008; and**
 3 **WHEREAS, the Baboquivari District Administration and Community Representatives of the six**
 4 **communities presents their FY 2009 budgets for review, discussion and approval; and**
 5 **WHEREAS, the Baboquivari District Council approved to utilize a 40%/60% formula and distribute**
 6 **the 2009 gaming allocations as 40% to Baboquivari District Administration in the**
 7 **amount of \$638,062.52 and 60% to the six communities, in the amount of \$170,765.65**
 8 **per community, for a total amount of \$1,707,656.42, per Baboquivari District**
 9 **Resolution # 08-B-85; and**
 10 **WHEREAS, the communities of Artesia/Little Tucson, Choulic, Coldfields, Fresno Canyon and**
 11 **South Komelic have also added to their budgets, final 08 gaming, mining royalties for**
 12 **08, and identified interest dollars from previous years; per Baboquivari District**
 13 **Resolution #'s 08-B-75 and 08-B-86; and**

3 **BE IT FURTHER RESOLVED** the Tohono O'odham Legislative Council recognizes, the Baboquivari
4 District's approval to utilize a 40%/60% formula and distribute the 2009 gaming
5 allocations as 40% to Baboquivari District Administration, in the amount of
6 \$638,062.52 and 60% to the six communities, in the amount of \$170,765.65 per
7 community, for a total District budget amount of \$1,707.656.42, per Baboquivari
8 District Resolution #08-B-85

9 **BE IT FINALLY RESOLVED** any modifications, amendments or changes in the justification of said
10 budgets, shall be reviewed and approved by the Budget and Finance Committee and
11 the Tohono O'odham Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day
13 of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
14 AGAINST; 0-NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section
15 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
16 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).


