

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo District FY 2009 Budget)

RESOLUTION NO. 08-571

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 08-490 approves FY 2009 District**
2 **Allocation and Apportionment of Gaming Revenues to Districts by equal distribution;**
3 **and**

4 **WHEREAS, a draft FY 2009 budget in the amount of \$1,707,656.42 was presented to the Pisinemo**
5 **District Council for review, comment and recommendations; and**

6 **WHEREAS, the draft FY 2009 budget was also taken out to the communities of San Simon,**
7 **Pisinemo, Santa Cruz, Kupk and Dirtburn for review and comments and then brought**
8 **back to the Pisinemo District Council for action; and**

9 **WHEREAS, the respective communities and Pisinemo District Council have approved the FY 2009**
10 **District Budget to be distributed as follows:**

11	Salaries	\$ 614,149.76
12	Fringe Benefits	\$ 151,760.94
13	District Operations	\$ 751,745.72
14	Community Budgets	\$ 120,000.00
15	Pisinemo Development Authority	\$ 70,000.00
16	Total	\$1,707,656.42

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
18 **approve the Pisinemo District FY 2009 District Budget in the amount of \$1,707,656.42.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation's Officials to wit; Chairman, Vice-Chairman and any designated official are**
21 **authorized to expend the budget, provided however, that any amendments affecting**
22 **the funds or funding levels of the budget shall be submitted to the Tohono O'odham**
23 **Legislative Council for further prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
25 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section**
27 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
