1	WHEREAS, Sells District did receive notification of the Fiscal Year 2009 Tohono O'odham Nation
2	Gaming Revenue Distributions for the Districts in the amount of \$1,707,656.42; and
3	WHEREAS, the Sells District Council at a Special Meeting held on September 9, 2008 did approve
4	by Resolution No. SD-94-08 the Sells District Fiscal Year 2009 Budget for the
5	Administration at a total of \$1,547,656.42 and the four communities Cowlic, Big Field,
6	North Communities and Sells at \$40,000.00 each for a grand total of \$1,707,656.42; and
7	WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee and the Tohono
8	O'odham Legislative Council did review and approve the Sells District Administration
9	and its Community Budgets.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
11	Sells District Fiscal Year 2009 Budget for the Administration, Cowlic Community, Big
12	Field Community, North Communities and the Sells Community in the amount of
13	\$1,707,656.42 which was allocated to the Sells District from the Tohono O'odham
14	Nation Gaming Revenue according to the attached budgets.
15	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
16	Chairperson and any designated official to expend and administer the budget, as
17	attached, provided that any modifications/amendments affecting the funds or funding
18	levels of the budget shall be submitted for further prior approval by the Tohono
19	O'odham Legislative Council.
25 26	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>23<sup>RD</sup>.</u> Day of <u>SEPTEMBER</u> , <u>2008</u> at a meeting at which a quorum was present with a vote of <u>2,534.5</u> FOR; <u>-0-AGAINST;-0-NOT VOTING</u> ; and <u>102</u>  ABSENT, pursuant to the powers vested in the Council by Section 1 ( <u>d)(2) &amp; (3)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
