

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Lucy District FY 2009 Budget)

RESOLUTION NO. 08-573

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with all legislative powers including**
2 **fiscal powers to adopt, approve, amend annual budgets and to authorize the**
3 **expenditure of funds; and**

4 **WHEREAS, annually the Legislative Council disburse gaming revenues to the districts upon which**
5 **to develop their annual budgets; and**

6 **WHEREAS, the San Lucy District Council prepared their FY 2009 Budget package in conjunction**
7 **with appropriate district personnel and has determined to provide a 3% COLA across**
8 **the board increase for district staff and elected district officials and 3% merit increase**
9 **for eligible staff members; and**

10 **WHEREAS, by Resolution No. 09-89-08, the San Lucy District Council approved the FY 2009 Budget**
11 **in the amount of \$2,690,556.18 and further identifies funding sources for the budget;**
12 **and**

13 **WHEREAS, the Budget and Finance Committee has reviewed the district's budget and is**
14 **forwarding it to the Legislative Council for their consideration.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative hereby approves the San**
16 **Lucy District's FY 2009 Budget in the amount of \$2,690,556.18.**

17 **BE IT FURTHER RESOLVED that monies from Gaming Revenues in the amount of \$1,703,322.20 and**
18 **interest from P.L. 99-503 in the amount of \$987,233.98 totaling \$2,690,556.18 shall be**
19 **the sources to fund the San Lucy District FY 2009 Budget.**

20 **BE IT FURTHER RESOLVED the balance of \$4,334.22 from the Gaming Revenue apportionment of**
21 **\$1,707,656.42 shall be incorporated in future FY 2009 San Lucy District budget(s) and**
22 **to be submitted to Tohono O'odham Legislative Council for approval.**

23 **BE IT FINALLY RESOLVED that bi-weekly disbursement of P.L. 99-503 funds are wire transferred to**
24 **the San Lucy District General Account at National Bank of Arizona, Gila Bend Branch.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
26 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**
28 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**




