

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving & Authorizing the Chukut Kuk District FY 2009 Budget)**

**RESOLUTION NO. 08-574**

1 **WHEREAS, the Chukut Kuk District did meet on August 25, 3008 in San Miguel at which a quorum**  
2 **of the District Council was present; and**

3 **WHEREAS, the District Council did approve the Chukut Kuk District FY 2009 Budget in the amount**  
4 **of \$2,127,025.76 by district Resolution No. 2008-41 attached hereto and incorporated**  
5 **herein by this reference; and**

6 **WHEREAS, the equal distribution of gaming revenues allocated to Chukut Kuk District in the**  
7 **amount of \$1,707,656.42 does not cover the FY 2009 district budget amount; and**

8 **WHEREAS, in fiscal year 2008 the Chukut Kuk District has been allocated Mining Royalties dollars**  
9 **in the amount of \$266,596.95 and 2008 Gaming Interest dollars in the amount of**  
10 **\$9,938.32, total allocation of Mining Royalties and 2008 Gaming Interest is \$276,535.27;**  
11 **and**

12 **WHEREAS, the Chukut Kuk district has added the Mining Royalties and 2008 Gaming Interest**  
13 **dollars as carry over dollars to the FY 2009 budget and it is identified as supplement**  
14 **dollars in the amount of \$276,535.27; and**

15 **WHEREAS, the Chukut Kuk District does have sufficient funds to cover the difference of**  
16 **\$142,834.07; and**

17 **WHEREAS, the Chukut Kuk District FY 2009 budget has been presented to the Tohono O'odham**  
18 **Legislative Council Budget & Finance committee for review.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative hereby approves the**  
20 **Chukut Kuk District FY 2009 Budget in the amount of \$2,127,025.76 and authorizes**  
21 **expenditures of these funds.**

22 **BE IT FURTHER RESOLVED that the funding for the Chukut Kuk District FY 2009 Budget will come**  
23 **from gaming revenues in the amount of, \$1,707,656.42, mining royalties in the amount**  
24 **of \$266,596.95 and 2008 gaming interest dollars in the amount of \$9,938.32 allocated**  
25 **to Chukut Kuk District in the amount of \$1,984,191.69.**

26 **BE IT FURTHER RESOLVED that the difference of \$142,834.07 will be funded from identified district**  
27 **funds.**

28 **BE IT FINALLY RESOLVED that any amendments affecting the funding levels of the Chukut Kuk**  
29 **District FY 2009 budget shall be submitted to the Tohono O'odham Legislative Council**  
30 **for further prior approval.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup>. Day**  
32 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
33 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
34 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
35 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
37 **Stat. 984).**
