

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY09 Budget in the amount of \$1,324,724.93 for the Hikiwan District Administration Operations; the Seven Communities of Hikiwan District in the amount of \$259,000.00; and Deposit Balance of Allocation in the Amount of \$180,353.91 into the Bank of America Savings for Hikiwan District)**

**RESOLUTION NO. 08-575**

1 **WHEREAS, the Tohono O'Odham Legislative Council by Res. No. 08-490 has apportioned to the**  
2 **Hikiwan District from the FY 2009 Gaming Revenues the Equal Distribution amount**  
3 **of \$1,707,656.42 and 25% of the Host Share in the amount of \$56,422.42 to a total of**  
4 **\$1,764,078.84; and**

5 **WHEREAS, the Hikiwan District Council has presented their FY09 Budgets to the Tohono O'Odham**  
6 **Legislative Council for approval in the amount of \$1,324,724.93 for District**  
7 **Operations, \$259,000.00 for the Seven Communities; and to deposit the balance of**  
8 **\$180,353.91 into the Bank of America Savings Account from the Gaming**  
9 **Distribution/Host Share of \$1,764,078.84; and**

10 **WHEREAS, the Hikiwan District Council, by Resolution No. HDC-08-044 has approved the FY09**  
11 **Budget for the District Administration Operations at \$1,324,724.93; and**

12 **WHEREAS, these seven Communities (Gehakah, Hikiwan, Hodai Son Vo, Schuchuligk, S-tuha Bidag,**  
13 **Vaya Chin, and Ventana) has also presented their FY09 Budgets in the amount of**  
14 **\$259,000.00 with \$37,000.00 per community and approved by Resolution No. HDC-08-**  
15 **048; and**

16 **WHEREAS, the Hikiwan District Council recommends the balance of \$180,353.91 for deposit into**  
17 **the Savings Account of the Hikiwan District.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby**  
19 **approves the Hikiwan District FY09 Budget in the amount of \$1,324,724.93 for Hikiwan**  
20 **District Operations and \$259,000.00 for the seven communities.**

21 **BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council hereby approves**  
22 **depositing the balance of \$180,353.91 into the Savings Account of the Hikiwan District.**

23 **BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'Odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day**  
28 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
30 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**
