1 **WHEREAS, the Tohono O'Odham Legislative Council passed Resolution No. 07-751, "Approving the**
2 **FY 2008 Apportionment of Mining Royalties by Equal Distribution"; and**

3 **WHEREAS, the Sif-Oidak District Council passed Resolution No. SODC-08-013 "Approving the FY**
4 **2008 Home Repair/Renovation Budget", on January 26, 2008; and**

5 **WHEREAS, the Tohono O'Odham Legislative Council passed Resolution No. 08-400 "Approving the**
6 **Sif-Oidak District FY 2008 Home Repair/Renovation Budget in the amount of**
7 **\$266,596.95 from the Mining Royalties", on June 30, 2008; and**

8 **WHEREAS, the FY 2008 Home Repair/Renovation Budget has not yet been expended until the**
9 **District Wide Housing Survey has been completed; and**

10 **WHEREAS, the Sif-Oidak District Council passed Resolution No. SODC 08-135, "Approving the FY**
11 **2008 Home Repair/Renovation Budget Carry Over to FY 2009.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby**
13 **approve the FY 2008 Sif-Oidak District Home Repair/Renovation Budget Carry Over**
14 **in the amount of \$266,596.95, effective FY 2009.**

15 **BE IT FINALLY RESOLVED that any changes affecting the funding or funding levels shall be**
16 **submitted for prior approval by the Tohono O'Odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 23RD Day**
18 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section**
20 **1 (d)2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
