

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2009 Sif-Oidak District Gaming Revenue Budget in the
amount of \$1,707,656.42)

RESOLUTION NO. 08-577

1 WHEREAS, the Tohono O'Odham Legislative Council passed Resolution No. 08-460, "Approving the
2 Allocation of Gaming Revenues by equal distribution in the amount of \$1,707,656.42";
3 and

4 WHEREAS, the Sif-Oidak District Council passed Resolution No. SODC-08-123 "Approving the FY
5 2009 Sif-Oidak District Gaming Revenue Budget in the amount of \$1,707,656.42"; and

6 WHEREAS, the Tohono O'Odham Legislative Budget and Finance Committee has reviewed the
7 Budget on September 23, 2008, and recommends approval.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby
9 approve the FY 2009 Sif-Oidak District Gaming Revenue Budget in the amount of
10 \$1,707,656.42 as follows:

11	ADMINISTRATION	\$1,492,713.93
12	SENIOR SERVICES	\$ 103,105.92
13	YOUTH SERVICES	\$ 111,836.57

14 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council does hereby authorize
15 the Tohono O'odham Nation's Treasurer to transfer \$1,707,656.42 to the Sif-Oidak
16 District's Wachovia Account to be expended.

17 BE IT FINALLY RESOLVED that any changes affecting the funding or funding levels shall be
18 submitted for prior approval by the Tohono O'Odham Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day
20 of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
21 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section
22 1 (d)2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
25 Stat. 984).


