

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment #1 to the Tohono O'odham Nation Fire Department Fiscal**  
**Year 2009 Carry Over Budget)**

RESOLUTION NO. 08-579

1 WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has  
2 deemed it critical and necessary to increase Fire Protection services to the Tohono  
3 O'odham Nation, particularly the new Desert Diamond Casino/Hotel; and

4 WHEREAS, the Tohono O'odham Legislative Council approved a supplemental request of  
5 \$4,055,700.00 for the construction of a Fire/Police substation, to fund fire apparatus  
6 and for other costs associated with additional staff; and

7 WHEREAS, the actual construction of the proposed Fire/Police substation will not begin until  
8 Fiscal Year 2009; and

9 WHEREAS, the construction of fire apparatus funded in Fiscal Year 2008 will not be completed in  
10 Fiscal Year 2008; and

11 WHEREAS, other costs associated with the increase in staffing remain; and

12 WHEREAS, the Tohono O'odham Legislative Council approved a \$2,635,870.00 carry over budget  
13 for the Fire Department for Fiscal Year 2009; and

14 WHEREAS, \$1,958,557.00 remains unexpended in fiscal Year 2008 funding.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves  
16 Amendment #1 to the Fire Department Fiscal Year 2009 Carry Over Budget in the  
17 amount of \$2,625,870.00 plus \$1,958,557.00 in unexpended Fiscal Year 2008 funds to  
18 bring the total amended Fiscal Year 2009 carry over budget to \$4,584,427.00 in  
19 accordance with the budget attached hereto.

20 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the  
21 Chairman and any designated official to expend and administer the budget as  
22 attached, provided that any amendments affecting the funds or funding level shall be  
23 submitted for further prior approval by the Tohono O'odham Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup>. Day  
25 of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
26 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section  
27 1 (d)2 & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
28 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
30 Stat. 984).
