

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving 2008 Budget Modification #2/Amendment #2 for Fresnal Canyon Community)

RESOLUTION NO. 08-580

1 WHEREAS, at a special session of the Tohono O'odham Legislative Council, held in September,
2 2008; and

3 WHEREAS, the Baboquivari District presented a budget modification #2/amendment #2 for
4 Fresnal Canyon's 2008 budget; and

5 WHEREAS, the budget was presented as follows:

10 WHEREAS, the net payment and fringe benefits of \$5,717.14 shall be pulled from salary and fringe
11 benefit savings; and

12 WHEREAS, after review and discussion, the Tohono O'odham Legislative Council did approve
13 Fresnal Canyon's 2008 budget modification #2/amendment #2, to utilize \$5,717.14
14 from salary and fringe benefit savings and apply to the three positions of community
15 supervisor and 2 community workers for net payments of \$100.00 per pay period from
16 6/8/08 to 9/30/08, and pay all taxes.

17 NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves Fresnal
18 Canyon's 2008 budget modification #2/amendment #2, to utilize a total of \$5,717.14
19 from salary and fringe benefit savings and apply to the positions of community
20 supervisor and 2 community workers for net payments of \$100.00 per pay period,
21 beginning 6/8/08 to 9/30/08, and to include all taxes.

22 BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications of
23 Baboquivari District budgets, shall be reviewed and approved by the Budget and
24 Finance Committee and the Tohono O'odham Legislative Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day
26 of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
27 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section
28 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
29 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
30 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
31 Stat. 984).
