

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for the 30 Day Continuation of Ali Chugk Community FY'2008 Budget
Pending FY'2009 Budget Approval)**

RESOLUTION NO. 08-582

1 **WHEREAS, the Gu-Vo District Governing Council did meet on September 20, 2008 to approve 30**
2 **Day Continuation for Ali Chugk Community Budget FY'2008 pending FY'2009 Budget**
3 **Approval; and**

4 **WHEREAS, the Gu-Vo District Governing Council has determined that it is in the best interest of**
5 **the Ali Chugk Community to request to the Tohono O'odham Legislative Council to**
6 **grant Ali Chugk Community the 30 Day Continuation of the FY'2008 Budget pending**
7 **FY'2009 Budget.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
9 **the Thirty Day Continuation of Ali Chugk Community Budget FY'2008 pending**
10 **approval of their FY 2009 Budget.**

11 **BE IT FURTHER RESOLVED that the Ali Chugk Community has sufficient funding in its FY 2008**
12 **Budget to continue operations during this Thirty Day Continuation.**

13 **BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its budget according**
14 **to the Tohono O'odham Nation's process, but any amendments affecting the funds or**
15 **funding levels shall be approved by the Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH. Day**
17 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**
19 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**


