

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving of the FY 2009 Education Department One Stop Division
Carry Over Training Budget)

RESOLUTION NO. 08-584

1 **WHEREAS, the Office of Indian Energy and Economic Development, Department of Interior from**
2 **Washington DC, has approved \$25,000.00 to the Tohono O'odham Nation to assist in**
3 **training and transitioning program services to expand and meet the new performance**
4 **needed under as an approved Education Department One Stop Division Training**
5 **Grantee; and**

6 **WHEREAS, the Education Department One Stop Division Training Program has been developed**
7 **with the Native Employment Works Program and the Arizona Department of Economic**
8 **Security funding to promote smooth transitional services for clients with an effective**
9 **staff cost share to promote and improve centralized services; and**

10 **WHEREAS, the Grants & Contract Office has identified that the One Stop Division Employment**
11 **Program has a remaining balance in the amount of \$10,194.69 in account # 11-2202**
12 **and now requires a new carry over budget for expenditure of travel, tuition and**
13 **registration; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
15 **reviewed the Education One Stop Division Training Budget.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **accept and approve the FY 2009 Carry Over Training Budget from the Office of Indian**
18 **Energy and Economic Development, Department of Interior in the amount of**
19 **\$10,194.69 to promote training and transitioning programming of services to meet the**
20 **needs of an Education Department One Stop Division.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation's Officials, to wit; the Chairman and any official appointed designee is hereby**
23 **authorized to expend the budget and plans, provided however, that any amendment**
24 **affecting the funding or funding levels of this budget shall be submitted for further**
25 **prior approval by this Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH. Day**
27 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section**
29 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
