

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Appropriating the FY 2009 Supplemental Budget for the Executive**  
**Branch Lobby Administrative Provisions Budget in the amount of \$235,000.00**  
**Amendment No. 1)**

**RESOLUTION NO. 08-589**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation ... and to appropriate these funds for the**  
3 **benefit of the nation and its members" provided that all expenditures of these funds**  
4 **shall be pursuant to appropriations or budgets authorized by resolutions or**  
5 **ordinances, (Constitution of the Tohono O'odham Nation, Article VI, Section 1 (d) (2);**  
6 **and**

7 **WHEREAS, the Legislative Council has approved an FY 2009 Lobby Administrative Provisions**  
8 **Budget in the amount of \$684,000; and**

9 **WHEREAS, there is an increasing demand for public relations services and contributions, and it**  
10 **has therefore been recommended that Public Relations line item 812 funding be**  
11 **increased by \$96,000 for an amended line item total of \$464,000; and**

12 **WHEREAS, there is a need for additional travel expenses for the Appropriations Committee, and**  
13 **it has therefore been recommended that Travel Expenses line item 660 funding be**  
14 **increased by \$5,000 for an amended line item total of \$15,000; and**

15 **WHEREAS, there is an increasing demand for state lobbying services and it has therefore been**  
16 **recommended that Lobby line item 811 funding be increased by \$134,000 for an**  
17 **amended line item total of \$440,000; and**

18 **WHEREAS, these increases in funding require an amended total budget amount of \$919,000 in**  
19 **accordance with the FY 2009 Lobby Administrative Provisions Budget Amendment No.**  
20 **1, which is incorporated by this reference; and**

21 **WHEREAS, the FY 2009 Lobby Administrative Provisions Budget Amendment No. 1 has been**  
22 **presented to and reviewed by the Budget and Finance Committee.**

23 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
24 **the attached supplemental budget for FY-2009 in the amount of \$235,000.00 from the**  
25 **FY 2009 General Revenue Projection for the FY 2009 Supplemental Budget for the**  
26 **Executive Branch Lobby Administrative Provisions Budget to be effective October 1,**  
27 **2008.**

28 **BE IT FURTHER RESOLVED that in accordance with the FY-09 Executive Branch Lobby**  
29 **Administrative Provisions Budget budget attached hereto in the amount of**  
30 **\$235,000.00 from the FY 2009 General Revenue Projection shall be integrated into the**

1                    **base budget and shall be recurring for future fiscal years.**  
2 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
3 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**  
4 **administer the attached budget, provided, however that any amendments affecting**  
5 **these funds or funding levels that are budgeted shall be submitted for prior approval**  
6 **by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
8 **of SEPTEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,247.45 FOR;**  
9 **287.05 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
10 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
11 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
13 **18, 1934 (48 Stat. 984).**




