1	WHEREAS.	the Legislative Council is authorized "to manage any funds within the exclusive
2		control of the Tohono O'odham Nation and to appropriate these funds for the
3		benefit of the nation and its members" provided that "[a]ll expenditures of these funds
4		shall be pursuant to appropriations or budgets" authorized by resolution or
5		ordinance (Constitution of the Tohono O'od ham Nation, Article VI, Section 1(d)(2)); and
6	WHEREAS,	on December 14, 2007, Title III of the Arizona Water Rights Settlement Act became
7		effective, thereby allocating 66,000 acre feet of water to the Nation and otherwise
8		authorizing the settlement of water claims relating to the San Xavier District and
9		eastern Schuk Toak District of the Tohono O'odham Nation; and
10	WHEREAS,	in recognition of the numerous tribal, federal, and state parties, officials, and
11		individuals who worked to achieve the passage and enforceability of Title III, the
12		Nation sponsored a Washington, D.C. reception, participated in a Arizona Water Rights
13		Settlement Act celebration on the Gila River Indian Community Reservation, and is
14		planning a celebration on the Nation for Nation's members; and
15	WHEREAS,	partial funding for the events held in Washington, D.C . and at the Gila River Indian
16		Community was provided through the Arizona Water Rights Settlement Act Budget
17		that was approved by Legislative Council Resolution No. 08-042, as amended by
18		Resolution No. 08-207 (approving AWSA Budget Amendment No. 1), ("AWSA Budget");
19		and
20	WHEREAS,	while the celebration for Nation's members is scheduled for December 14, 2008, the
21		authority to expend funds under the AWSA Budget expires September 30, 2008; and
22	WHEREAS,	the Water Resources Committee has therefore recommended that the Legislative
23		Council approve the carry-over amount of \$9,147.26, which is the unexpended funds
24		from the AWSA Budget, through March 1, 2009 to allow the budgeted funds to be used
25		for a celebration for Nation's members.
26	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
27		the carry-over of \$9,147.26 in SAWRSA Trust Account funds and extends expenditure
28		authority in that amount under the AWSA Budget through March 1, 2009; provided that
29		(1) The AWSA Budget shall continue to be administered by the Tohono O'odham
30		Legislative Administration with expenditures approved by the Tohono O'odham
31		Legislative Council Water Resources Committee.
