

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2009 TOPD Asset Forfeiture Program budget from the Department
of Treasury and the Department of Justice Accounts for the Tohono O'odham
Nation Police Department)

RESOLUTION NO. 08-599

1 **WHEREAS, pursuant to Legislative Council Resolution No. 01-128; 03-085; 04-249 concerning the**
2 **use of Asset Forfeiture Funds; and**

3 **WHEREAS, the Tohono O'odham Nation Police Department is requesting for the authorization**
4 **and expenditure of funds to purchase vehicles to include radio equipment, decals,**
5 **and other accessories to outfit the vehicles for use by Commissioned, Ranger & Canine**
6 **personnel; and**

7 **WHEREAS, this amount will be cost shared under both accounts in the amount of \$146,000.00 for**
8 **the Department of Justice and \$161,000.00 from the Department of Treasury; and**

9 **WHEREAS, the total cost of this acquisition is estimated at \$307,000.00.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
11 **and approves the authorization and expenditure for the acquisition to purchase**
12 **vehicles including accessories for the total budgeted amount of \$307,000.00 as**
13 **attached hereto funding to be supported from Asset Forfeiture Fund Account -**
14 **Department of Treasury 161,000.00 and Account - Department of Justice \$146,000.00**
15 **a total of \$307,000.00.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
17 **Chairman, Vice-Chairman and any designated officials are authorized to administer**
18 **the attached budget, provided, however that any amendments affecting these funds**
19 **or funding levels that are budgeted shall be submitted for prior approval by the**
20 **Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
22 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 2,534,5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section**
24 **1 (d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**
