

30 **in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.**

31 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 08TH. Day**
32 **of OCTOBER, 2008 at a meeting at which a quorum was present with a vote of 1,712.2 FOR; 822.3**
33 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
34 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**
35 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
36 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
37 **of the Act of June 18, 1934 (48 Stat. 984).**
